



## **Hospice of the Valleys Cardiff Half Marathon Charity place – Terms and Conditions**

For this event you pledge to raise a minimum of £200 (excluding gift aid or registration fees where applicable) in sponsorship money for Hospice of the Valleys, which should be received by Hospice of the Valleys within one month of the event. All funds raised through the event must be payable to Hospice of the Valleys in £ sterling. The objective is to enjoy the event whilst raising as much sponsorship as possible.

### **All participants:**

You confirm that you are medically fit and that you participate in the event at your own risk. In making the decision to take part you are satisfied that this activity is suitable for you as an individual. Hospice of the Valleys cannot be held accountable for aggravation to illness or injury sustained due to participation in this event. You are recommended to seek advice from your medical practitioner prior to taking part in this event, and make provisions to ensure your safe participation.

You understand that it is your responsibility to read any terms and conditions and documentation issued by the race organisers and to comply with these.

You are fully responsible for your actions whilst attending the event. This includes the event centre and during the event itself. Hospice of the Valleys does not accept responsibility for your actions nor the consequences of such actions.

You accept that Hospice of the Valleys will not be liable for any loss, damage, action, claim, costs or expenses which may arise from your participation in this event.

You have provided Hospice of the Valleys information about you and consent to the Hospice using this data. You understand that it will be necessary for the Hospice to share the data with the race organisers in order to participate in this event.
